18 1. On or about October 16, 2017, Leeza Referedi, solely in her official capacity as the  
19 Deputy Chief of the Bureau for Private Postsecondary Education (Bureau), Department of  
20 Consumer Affairs, filed Statement of Issues No. 1002561. Dr. Michael Marion, Jr. solely in his  
21 official capacity as the Chief of the Bureau, continues to prosecute this matter.

22 2. On or about June 14, 2013, the Bureau for Private Postsecondary Education received  
23 an Application for Renewal of approval to Operate and Offer Educational Programs for Non-  
24 Accredited Institutions from VIP Nursing School, Inc. (Respondent). After several notices of  
25 deficiencies and some further information from Respondent, the Bureau denied the application on  
26 March 24, 2017.


27 3. The basis for withdrawing the pending Statement of Issues number 1002561 is that
