## LICENSING HISTORY

1. On or about October 18, 2019, the Bureau renewed an Approval to Operate a Private Postsecondary Institution, Institution Code 53555857, to Pathways College, L.L.C., Nursing and Health Care Careers (formerly known as Pathways College, L.L.C.), hereinafter referred to as the "Institution." This Approval to Operate will expire on or about October 17, 2024, unless renewed.

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

## CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

If you wish to contest this citation, you may submit a written request to the Bureau or submit the enclosed Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing form within <u>30 days</u> from the date of issuance of this citation.

Failure to submit a written request for an informal conference and/or administrative hearing within <u>30 days</u> from the date of issuance of this citation will forfeit your ability to appeal the citation.

If a hearing is requested, you are not required to comply with this citation until a final order is entered against you.

#### COMPLIANCE WITH FINE AND/OR ORDER OR ABATEMENT DISCLOSURE
