4. The Institution is in violation of the following Bureau laws and regulations:

5 CCR 71930 (c)(3); (c)(4); and (e) – Maintenance of Records

Cause for Citation: On or about September 17, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a) at the Institution's approved physical address on record with the Bureau. Bureau staff made attempts to contact the Institution by phone to gain access to the Institution for the unannounced compliance inspection but did not receive a response. Bureau staff determined that the Institution did not have personnel present during normal business hours for the unannounced compliance inspection and failed to have records immediately available for inspection during normal business hours.
