#### **JURISDICTION**

3. This Accusation is brought before the Director of the Department of Consumer Affairs (Director) for the Bureau, under the authority of the following laws. All section references are to the Education Code (Code) unless otherwise indicated.

### STATUTORY PROVISIONS

- 4. Business and Professions Code section 23.7 states, "Unless otherwise expressly provided, "license" means license, certificate, registration, or other means to engage in a business or profession regulated by this code or referred to in Section 1000 or 3600."
  - 5. Section 94932 of the Code states:

The bureau shall determine an institution's compliance with the requirements of this chapter. The bureau shall have the power to require reports that institutions shall file with the bureau in addition to the annual report, to send staff to an institution's sites, and to require documents and responses from an institution to monitor compliance. When the bureau has reason to believe that an institution may be out of compliance, it shall conduct an investigation of the institution. If the bureau determines, after completing a compliance inspection or investigation, that an institution has violated any applicable law or regulation, the bureau shall take appropriate action pursuant to this article.

- 6. Section 94934 of the Code states:
- (a) As part of the compliance program, an institution shall submit an annual report to the bureau, under penalty of perjury, signed by a responsible corporate officer, by July 1 of each year, or another date designated by the bureau, and it shall include the following information for educational programs offered in the reporting period:
  - (1) The total number of students enrolled by level of degree or for a diploma.
    - (2) The number of degrees, by level, and diplomas awarded.
    - (3) The degree levels and diplomas offered.
  - (4) The Student Performance Fact Sheet, as required pursuant to Section 94910.
    - (5) The school catalog, as required pursuant to Section 94909.
  - (6) The total charges for each educational program by period of attendance.
  - (7) A statement indicating whether the institution is, or is not, current in remitting Student Tuition Recovery Fund assessments.
    - (8) A statement indicating whether an accrediting agency has taken any

1	(6) The total percentage of institutional income that comes from any public funding sources; and
2	(7) A blank copy of the institution's enrollment agreement and the catalog for the reporting year.

4	(b) In addition to the information required by section 94934 of the Code and this section provided under penalty of perjury, the institution shall have annual financial statements prepared for the institution's prior fiscal year and signed under
5	penalty of perjury, and shall submit a hard copy under separate cover of such statements in conjunction with its annual report. The form, content and mode of
6	preparation of financial statements shall comply with Section 74115 of this Division.  The Bureau may request that the institution immediately make available for
7	inspection to a representative of the Bureau, these financial statements at the offices of the institution.
8	
9	(c) As part of its annual report to the Bureau, every institution shall provide graduate identification data for each student who graduated from the institution's educational program(s), which shall include:

11	(1) The graduate's name and federal taxpayer identification number, which is either the graduate's social security number (SSN) or individual taxpayer identification number (ITIN). If the graduate does not have an SSN or
12	ITIN, the graduate's information shall be reported as "not available";
13	(2) The date of graduation;
14	(3) The following information regarding the educational program in which the graduate was enrolled:
15	(A) The federal Bureau of Labor Statistic's Standard Occupation
16	Classification (SOC) codes for which the institution has identified that the program prepares its graduates when required for the reporting of job
17	placement rates under subdivision (i)(3) of section 74112 of this Division;
18	(B) Educational program's name;
19	(C) Program length, as measured in clock hours or credit hours; and
20	(D) Type or title of degree, diploma or certificate awarded.
21	(4) The amount of federal student loan debt for the graduate, if any, as reported by the institution under subdivision (g) of section 74112 of this
22	Division.
23	(d) Specific Timeframes for Reporting Graduate Identification Data:
24	(1) The written notice required by Section 94892.6(b)(5) of the Code
25	shall inform the institution that the Director has certified that the Bureau's information technology system has been updated and is capable of processing the data required by that Section and that the institution has 120 days from
26	receipt of the notice to comply with this section.
27	(2) The first annual report submitted by an institution that contains the
28	graduate identification data required to be reported in subsection (c) shall include information collected on all students who graduated from January 1,

1	2020 through the end of the prior calendar year. Subsequent annual reports containing graduate identification data filed by an institution shall include information about students who graduated in the prior calendar year only.
2	(a) An institution shall file its annual report by December 1st of each year. The
3	(e) An institution shall file its annual report by December 1st of each year. The Bureau may extend the period for filing if the institution demonstrates evidence of
4	substantial need but in no case longer than 60 days. The institution shall not change the date of its filing its annual report because of a change in the fiscal year without the Bureau's approval.

6	(f) The annual report shall be electronically filed by submitting the information required by section 94934 of the Code and this section via the Bureau's online annual reports portal designated on the Bureau's website at: www.bppe.ca.gov, and
7	electronically uploading, as directed, the School Performance Fact Sheet, the enrollment agreement, the school catalog and the graduate identification data required
8	by this section. The following conditions relate to such electronic filings:
9	(1) Institutions submitting their annual report submission shall first have a responsible institution representative register the institution for a user account

24	(4) Electronic Signature: When a signature is required by the particular
25	instructions of any filing to be made through the online portal, including any attestation under penalty of perjury as required by Section 94934 of the Code,
26	a responsible institutional representative of the institution shall affix their electronic signature to the filing by typing their name in the appropriate field

26	14. Section 94937, subdivision (c), of the Code states, "The bureau may seek
27	reimbursement pursuant to Section 125.3 of the Business and Professions Code."

15. Section 125.3 of the Code provides, in pertinent part, that the Board may request the administrative law judge to direct a licensee found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case, with failure of the licensee to comply subjecting the license to not being renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be included in a stipulated settlement.

#### FIRST CAUSE FOR DISCIPLINE

# (Failure to Comply with Citation No. 2223097)

- 16. Respondent is subject to disciplinary action under Code section 94936, in conjunction with Regulation 75050, subdivision (b), in that Respondent failed to comply with Citation No. 2223097 issued to Respondent on March 20, 2023. The circumstances are as follows:
- 17. The Bureau issued Citation No. 2223097 after Respondent failed to submit the 2021 Annual Report, which was due to the Bureau by December 1, 2022. The citation included a \$5,000.00 administrative fine and an Order of Abatement to submit the 2021 Annual Report. Compliance with the citation was due thirty days from the date of issuance of the citation. Respondent did not appeal the Citation. The Bureau mailed demand letters for payment of the administrative fine and compliance with the Order of Abatement on May 8, 2023, June 21, 2023, and August 11, 2023. On January 12, 2024, the Bureau offered Respondent a payment plan, to pay the administrative fine over twelve monthly payments. Respondent failed to sign and return the payment plan to the Bureau. To date, Respondent has failed to comply with Citation No. 2223097.

#### **SECOND CAUSE FOR DISCIPLINE**

## (Failure to Comply with Citation No. 23240239)

- 18. Respondent is subject to disciplinary action under Code section 94936, in conjunction with Regulation 75050, subdivision (b), in that Respondent failed to comply with Citation No. 23240239 issued to Respondent on April 3, 2024. The circumstances are as follows:
- 19. The Bureau issued Citation No. 23240239 after Respondent failed to submit its 2022 Annual Report and its Student Tuition Recovery Fund (STRF) Assessment Reporting Form and

applicable fees for the fourth quarter reporting period of 2023. The Bureau issued an administrative fine of \$6,000.00 and included an Order of Abatement to submit the 2022 Annual Report and delinquent STRF. The Respondent did not appeal the Citation. To date, Respondent has failed to comply with Citation 23240239.

#### THIRD CAUSE FOR DISCIPLINE

## (Failure to Notify Bureau of Substantive Change)

20. Respondent is subject to disciplinary action under Code sections 94893 and 94894 in that on or about December 12, 2023, Respondent's owner, Vollmer University, Inc., filed a Certificate of Dissolution with the California Secretary of State, without notifying the Bureau at any time of its change in business organization or ownership.

## **DISCIPLINE CONSIDERATIONS**

- 21. To determine the degree of discipline, if any, to be imposed on Respondent, Complainant alleges that on or about July 14, 2021, in a prior action, the Bureau issued Citation No. 2122006<sup>1</sup> for failure to submit an STRF assessment for first quarter of 2021, and failure to pay a late payment penalty fee for having paid the 2021 Annual Fee late. Citation No. 2122006 ordered Respondent to submit the delinquent STRF Assessment Reporting Form with the STRF Assessments collected from students for the first quarter of 2021, pay all late payment penalty fees, and pay a \$50 administrative penalty. That Citation is now final.
- 22. To determine the degree of discipline, if any, to be imposed on Respondent, Complainant alleges that on or about November 14, 2022, in a prior action, the Bureau issued Citation No. 2223033 for failure to submit STRF Assessment Reporting Forms for the third and fourth quarters of 2021 and the second and third quarters of 2022, and for failure to pay a late payment penalty fee for the 2022 Annual Fee. Citation No. 2223033 ordered Respondent to submit the delinquent STRF Assessment Reporting Forms with the STRF Assessments collected from students, to pay the remaining balance for its 90-day late payment penalty fees for the 2022 Annual Fee, and to pay a \$501.00 administrative penalty. That Citation is now final.

Revoking or suspending Approval to Operate Institution Code No. 14961533 issued to Vollmer University, owned by Vollmer University Inc.; 6 7 2. Ordering Vollmer University to pay the Bureau for Private Postsecondary Education the reasonable costs of the investigation and enforcement of this case, pursuant to Business and 8 Professions Code section 125.3; and, 9 3.
