Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to Bodhi Panya LLC., Owner of Bodhi Panya Institute (Institution) located at 38 Bryant St., Suite 2, San Francisco, CA 94105, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

On December 10, 2021, Bureau staff attempted to conduct an Unannounced Compliance Inspection at the Institution at approximately 9:15 a.m. Upon arrival, Bureau staff was unable to obtain entry into the Institution. Bureau staff was unsuccessful at attempting to reach the Institution’s personnel by calling the numbers on file with the Bureau. Bureau staff also attempted to visit the Satellite location located at 480 2nd Street, Suite 200, San Francisco, CA 94107, however the gate was locked. Bureau staff was unable to conduct the unannounced Compliance Inspection at both the Main and Satellite locations and left at approximately 10:30 a.m.

VIOLATION

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
1.	<p>Violation: CEC Section 94932.5 – Announced and Unannounced Compliance Inspections <i>“(a) As part of its compliance program, the bureau shall perform announced and unannounced inspections of institutions at least every five years.”</i></p> <p>5, CCR Section 71930 (e) – Maintenance of Records</p>

“(e) All records that the institution is required to maintain by the Act or this chapter shall be made immediately available by the institution for inspection and copying during normal business hours by the Bureau and any entity authorized to conduct investigations.”

On December 10, 2021, Bureau staff attempted to conduct an unannounced Compliance inspection at the Institution. Bureau staff attempted to enter the school site at 38 Bryant St., Suite 2, San Francisco, CA 94105, however the door was locked. The main door entrance had a sign posted with directions to proceed to the satellite location, located at 480 2nd Street, Suite 200, San Francisco, CA 94107, if the door was locked

Bureau staff attempted to call the Institution, Institution’s owners, Agent for Process, and Custodian of Records, however there was no answer at any of the phone numbers.

Bureau staff arrived at the satellite location and found that the building had a locked gate and Bureau staff could not gain access.

Bureau staff left at approximately 10:30 a.m.

The Institution’s website states that business hours are Monday-Friday 9:00 a.m.-6:00 p.m. Bureau staff was unable to review required documents, as documents were not made readily available due to the institution being closed during their normal business hours.

Order of Abatement:

The Bureau orders the Institution to submit the Institution’s Main and Satellite location business hours, as well as a policy, or procedure, of how future compliance will be maintained per 5, CCR Section 71930.

Assessment of Fine

The fine for this violation is \$5,000.00

TOTAL ADMINISTRATIVE FINE DUE: \$5,000.00

ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of **\$5,000.00** for the violations described above.

Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within 30 days from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.*

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **June 24, 2022**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **May 25, 2022**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **June 24, 2022**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
