LICENSING HISTORY

1. On or about September 3, 2021, the Bureau issued an Approval to Operate a Private Postsecondary Institution, Institution Code 67292104, to Savvy Beauty Academy, hereinafter referred to as the "Institution". This Approval to Operate will expire on or about September 3, 2026, unless renewed.

CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CITATION HISTORY

for an informal conference and an administrative hearing. The Bureau held the informal conference on March 11, 2024, and the citation was affirmed as a result of the informal conference. The Affirmed Citation Order was issued on March 14, 2024. The Institution requested the Bureau move forward with the appeal for an administrative hearing; however, the Bureau offered settlement options in lieu of the administrative hearing, which were accepted by the Institution. As settlement of Affirmed Citation No. 23240189, the Institution agrees to withdraw its request for an Administrative Hearing and agrees to a Settlement of Affirmed Citation No. 23240189 as follows:

CAUSE FOR CITATION & MODIFIED ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 74006 (a), (b) – Annual Fee in conjunction with CEC section 94931(b) – Late Payment

Cause for Citation: The Institution failed to pay its annual fee and 90-day late payment penalty fee for the 2023 calendar year.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$1,000.00.

Administrative Fine: The administrative fine for this violation has been modified from \$1,000.00 to \$250.00. The Administrative Fine has been satisfied.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to pay its annual fee and 90-day late payment penalty fee for the 2023 calendar year.
