LICENSING HISTORY

On or about May 15, 2020, the Bureau renewed an Approval to Operate a Private Postsecondary Institution, Institution Code 0107131, to Amfasoft Corporation (formally known as AMFASOFT CORPORATION), hereinafter referred to as the "Institution." request for an informal conference. The informal conference was held on November 12, 2024. No new substantive facts were presented during the informal conference; therefore, the Bureau affirms Citation No. 24250109.

CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR 71930 (e) - Maintenance of Records

Cause for Citation: On or about May 15, 2024, the Bureau attempted to conduct an unannounced compliance inspection pursuant to CEC 94932.5 (a) at the Institution's approved physical address on record with the Bureau. Bureau staff made attempts to contact the Institution by phone in order to gain access to the Intuition for an unannounced compliance inspection but did not receive a response. Bureau staff determined that the Institution did not have personnel present during normal business hours for the unannounced inspection and failed to have records immediately available for inspection during normal business hours.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.
