Elizabeth Elias issues this citation in her official capacity as Enforcement Chief of the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

LICENSING HISTORY

1. On or about April 20, 2016, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to IPSB at Life Energy Institute. This Approval to Operate expired on or about April 20, 2021, and has not been renewed. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on May 20, 2021, and is under review.

On January 8, 2024, The Bureau approved a change of name from IPSB at Life Energy Institute to IPSB School of Integrative Psycho-Structural Bodywork (hereinafter referred to at the "Institution").

If a hearing is requested, you are not required to comply with this citation until a final order is entered against you.
