Elizabeth Elias issues this citation in her official capacity as Enforcement Chief of the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

### LICENSING HISTORY

On or about September 20, 2012, the Bureau granted a Full Approval to Operate a Private Postsecondary Institution to D'Lacreme School of Cosmetology and Barbering (hereinafter referred to as the "Institution"). From August 16, 2017 to May 31, 2021, the Bureau granted an Accredited Institution Approval to Operate to the Institution. Subsequently, on or about November 4, 2021, the Bureau granted a new Full Approval to Operate a Private Postsecondary Institution to the Institution. This Approval to Operate will expire on or about November 4, 2026, unless renewed.

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

# CAUSE FOR CITATION & ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

### Violation #1:

# CEC Section 94906 - Language Enrollment Agreement

Cause for Citation: On or about July 14, 2022, the Bureau received a complaint alleging, in part, that the Institution failed to provide an enrollment agreement in Spanish upon enrollment. Evidence collected during the investigation determined that the recruitment leading up to enrollment was conducted in Spanish and English and when the student requested the enrollment agreement in Spanish, the request was denied. Therefore, the Institution failed to comply with CEC section 94906. A student shall have the right to obtain a clear explanation of the terms and conditions and all cancellation and refund policies in his or her primary language, and receive the enrollment agreement, disclosures, and statements in the language the recruitment was conducted in.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a written policy, or procedure, of how the Institution will maintain future compliance with CEC Section 94906.

### Violation #2:

# CCR Section 71770 (a) – Admission Standards and Transferred Credits Policy

Cause for Citation: On or about July 14, 2022, the Bureau received a complaint. Evidence collected during the investigation determined that the Institution admitted a student to an English language Cosmetology program, despite indications of minimal English proficiency. The Institution failed to obtain documentation (i.e., high school diploma or its equivalent, or otherwise meet the institution's criteria for a qualified candidate for admission, including minimum levels of prior education, preparation, skills, or training) indicating the student was sufficiently proficient in English and had a reasonable prospect of completing the program.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2501.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a written policy, or procedure, of how future compliance with 5, CCR sections 71770.

If you wish to contest this citation, you may submit a written request to the Bureau or submit the enclosed *Notice* of *Appeal* of *Citation* – *Request for Informal Conference and/or Administrative Hearing* form within 30 days from the date of issuance of this citation.

Failure to submit a written request for an informal conference and/or administrative hearing within 30 days from the date of issuance of this citation will forfeit your ability to appeal the citation.

If a hearing is requested, you are not required to comply with this citation until a final order is entered against you.
