CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 74006 (a), (b) – Annual Fee in conjunction with CEC 94931(b) – Late Payment

Cause for Citation: On May 2, 2024, the Bureau received payment from the Institution for its annual fee for calendar year 2024. However, the payment was returned to the Bureau as dishonored. To date, the Institution has failed to pay its annual fee and 90-day late payment penalty fee for the 2024 calendar year.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$1,000.00.
