Christina Villanueva issues this Citation and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

### CITATION

A Citation is hereby issued to Explore Beyond ESL, Inc, Owner of Explore Beyond ESL, Inc. located at 400 Corporate Pointe, Culver City, CA 90230 pursuant to Business and Professions Code section 125.9; California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 for the violations described below.

### BACKGROUND

Pursuant to CEC Section 94923(a) The Student Tuition Recovery Fund relieves or mitigates economic loss suffered by a student while enrolled in an institution not exempt from this article pursuant to Article 4 (commencing with Section 94874), who, at the time of his or her enrollment, was a California resident or was enrolled in a California residency program, prepaid tuition, and suffered economic loss.

All institutions are required to submit a Student Tuition Recovery Fund (STRF) Assessment Reporting Form to the Bureau no later than the last day of the month following the close of the quarter.

The Bureau sends notifications/reminders to all approved institutions prior to close of each quarter. As of April 30, 2018, Explore Beyond ESL, Inc, Institution code 44336765 has not submitted the STRF Assessment Reporting Form for the 1<sup>st</sup> and 4<sup>th</sup> quarters for 2016 and 1<sup>st</sup> and 4<sup>th</sup> quarters for 2017.

Pursuant to CEC Section 94930.5 (d)(1)(A). An annual fee for each campus designated by the Institution as a main campus location in California, in an amount equal to 0.45 percent of the

campus' total gross revenue derived from students in California, but not to be less than two thousand five hundred dollars (\$2,500) and not to exceed sixty thousand dollars (\$60,000). (B) An annual campus fee for each branch of the Institution in an amount equal to 0.45 percent of the branch's total gross revenue derived from students in California, but not to be less than two thousand five hundred dollars (\$2,500) and not to exceed sixty thousand dollars (\$60,000).

All institutions are required to pay the annual fee within 30 days of the date on which the Institution originally receives its approval to operate and each year thereafter on the anniversary of the date of the original approval. An institution shall pay its annual fee in addition to any other applicable fees. As of April 30, 2018, the Bureau has not received the annual fee for the 2017 calendar year from Explore Beyond ESL, Inc. (Institution), Institution Code 44336765.

VIOLATION

1.	<p><b>Violation:</b></p> <p>5, CCR Section 76130 (a-e)– Collection and Submission of Assessments</p> <p><i>“(a) A qualifying institution shall collect the assessment from each student in an educational program at the time it collects the first payment from or on behalf of the student at or after enrollment. The assessment shall be collected for the entire period of enrollment, regardless of whether the student pays the institutional charges in increments.</i></p> <p><i>(b) A qualifying institution shall complete the STRF Assessment Reporting Form (Rev. 2/10) and remit it with the STRF assessments collected from students to be received by the Bureau no later than the last day of the month following the close of the quarter as follows:</i></p> <p><i>(1) April 30 for the first quarter,</i></p> <p><i>(2) July 31 for the second quarter,</i></p> <p><i>(3) October 31 for the third quarter, and</i></p> <p><i>(4) January 31 for the fourth quarter. If the due date falls on a Saturday, Sunday or State or federal holiday, the due date shall be extended to the next regular business day for the Bureau.</i></p> <p><i>If the due date falls on a Saturday, Sunday, or State or federal holiday, the due date shall be extended to the next regular business day for the Bureau.</i></p> <p><i>(c) The STRF Assessment Reporting Form shall contain the following information:</i></p> <p><i>(1) Total number of students who signed enrollment agreements for educational programs during the reporting period; and</i></p> <p><i>(2) Total number of students eligible for STRF who signed enrollment agreements for educational programs during the reporting period; and</i></p> <p><i>(3) The total number of students who signed their enrollment agreement during the reporting period, were eligible for STRF, and who made their first payment during the reporting period; and</i></p> <p><i>(4) The total number of students who signed their enrollment agreement in a previous reporting period, were eligible for STRF, and who made their first payment during the current reporting period; and</i></p> <p><i>(5) Total amount of institutional charges after rounding each student's institutional charges to the nearest \$1,000, for all eligible STRF students whose STRF assessment was collected in the reporting period; and</i></p> <p><i>(6) Current contact telephone number of the person preparing the form; and</i></p> <p><i>(7) A declaration dated and signed under penalty of perjury by the person preparing the form that the form and any attachments are true and correct.</i></p> <p><i>(d) In the event of a school closure, any collected assessments shall be remitted to the Bureau within</i></p>

seven days following the cessation of instruction.

*(e) Submission of all prior reports and assessments required by this section is a condition of renewal."*

The Institution has failed to submit STRF for the following quarters: 1<sup>st</sup> and 4<sup>th</sup> quarter for 2016, and 1<sup>st</sup> and 4<sup>th</sup> quarter for 2017.

On April 1, 2016, the Institution was notified via mail at 400 Corporate Pointe, Culver City, CA 90230, that the STRF Assessment Reporting Form for the 1<sup>st</sup> quarter of 2016 was due. As of April 30, 2018, the Bureau has not received the STRF Assessment Reporting Form from the Institution.

On January 3, 2017, the Institution was notified via mail at 400 Corporate Pointe, Culver City, CA 90230, that the STRF Assessment Reporting Form for the 4<sup>th</sup> quarter of 2016 was due. As of April 30, 2018, the Bureau has not received the STRF Assessment Reporting Form from the Institution.

On April 3, 2017, the Institution was notified via mail at 400 Corporate Pointe, Culver City, CA 90230, that the STRF Assessment Reporting Form for the 1<sup>st</sup> quarter of 2017 was due. As of April 30, 2018, the Bureau has not received the STRF Assessment Reporting Form from the Institution.

On January 2, 2018, the Institution was notified via mail at 400 Corporate Pointe, Culver City, CA 90230, that the STRF Assessment Reporting Form for the 4<sup>th</sup> quarter of 2017 was due. As of April 30, 2018, the Bureau has not received the STRF Assessment Reporting Form from the Institution.

**Order of Abatement:**

The Bureau orders that the Institution submit the delinquent STRF Assessment Reporting Forms with the STRF Assessments collected from students for the quarters listed. The Institution shall also submit the student information to substantiate the data reported on the STRF Assessment Reporting Form(s). The information provided shall comply with "Record Keeping Requirements" Pursuant to 5, CCR section 76140.

The fine for this violation is [\$50.00]

2. **Violation:**

**5, CCR Section 74006(a) and (b) - Annual Fee**

*"(a) An institution's annual fee is due within 30 days of the date on which the institution originally receives its approval to operate and each year thereafter on the anniversary of the date of the original approval. (b) An institution shall pay its annual fee in addition to any other applicable fees.*

**CEC 94930.5 (d)(1)(A) - Fee Schedule**

*(d) (1) In addition to any fees paid to the bureau pursuant to subdivisions (a) to (c), inclusive, each institution that is approved to operate pursuant to this chapter shall remit both of the following:*

*(A) An annual fee for each campus designated by the institution as a main campus location in California, in an amount equal to 0.45 percent of the campus' total gross revenue derived from students in California, but not to be less than two thousand five hundred dollars (\$2,500) and not to exceed sixty thousand dollars (\$60,000).*

*(B) An annual campus fee for each branch of the institution in an amount equal to 0.45 percent of the branch's total gross revenue derived from students in California, but not to be less than two thousand five hundred dollars (\$2,500) and not to exceed sixty thousand dollars (\$60,000)."*

CEC 94931(a) or (b) - Late Payment

*"(a) A fee that is not paid on or before the 30<sup>th</sup> calendar day after the due date for the payment of the fee shall be subject to 25 percent late payment penalty fee."*

*"(b) A fee that is not paid on or before the 90<sup>th</sup> calendar day after the due date for payment of the fee shall be subject to a 35 percent late payment penalty fee."*

On November 2, 2011, the Institution was notified (invoice #900329403) via mail at 400 Corporate Pointe, Culver City, CA 90230, that the annual fee for calendar year 2017 was due on December 1, 2017. As of April 30, 2018, the Bureau has not received the annual fee from the Institution.

On January 16, 2018, the Institution was mailed a delinquency notification (invoice #900331163) via mail at 400 Corporate Pointe, Culver City, CA 90230, that the annual fee for calendar year 2017 was due on December 1, 2017. As of April 30, 2018, the Bureau has not received the annual fee from the Institution.

The Institution failed to pay its annual fee for the year 2017.

**Order of Abatement:**

The Bureau orders the Institution to submit its annual fee for 2017 in accordance with 5, CCR section 74006(a)(b) and CEC section 94930.5(d)(1)(A) In addition, the Institution must pay all late payment penalty fees.

In accordance with the provisions of CEC Section 94936 and 5 CCR Section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference **and/or** Administrative Hearing' form (enclosed) within 30 days from the date

of service of the Citation. *If you do not request an informal conference **and/or** an administrative hearing within 30 days from the service of the Citation, you will not be able to request one later.*

Unless a written request for an informal conference **and/or** an administrative hearing is signed by you and delivered to the Bureau by **May 30, 2018**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **April 30, 2018**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **May 30, 2018**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
