22 1. On May 6, 2020, Deborah Cochrane, Chief of the Bureau for Private Postsecondary
23 Education, Department of Consumer Affairs through her predecessor, filed Statement of Issues
24 No. 1005588 solely in her official capacity.

25 2. On or about April 26, 2019, the Bureau for Private Postsecondary Education (Bureau)
26 received an Application for Renewal of Approval to Operate an Institution Non-Accredited from
27 L.A. Vocational Institute, Vanouhi Vana Godjabashian, Owner. (Respondent). After notices of

1 deficiencies, on or about December 16, 2019, the Bureau denied the Application. The Bureau
2 received a letter from Respondent requesting an administrative hearing.

3 3. Statement of Issues number 1005588 was filed and is now pending. Respondent has
4 now provided the documents and other information necessary to cure all deficiencies in its
5 application and receive a Renewal of Approval to Operate an Institution Non-Accredited.

7 WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues number 1005588
8 is hereby withdrawn without prejudice effective upon signature.
