2	CEC §94909(a)(3)(A)	<p>Violation Description: Although page 3 of the institution’s catalog, contains the required disclosure however, the statement references the Bureau’s old address and the old telephone number, additionally catalog pages 3, 10, 14, 16 and 24 reference to Bureau’s old address and the old phone number.</p> <p>Correction: The institution shall update the catalog to include the Bureau’s current address (1747 North Market Boulevard, Suite 225, Sacramento, California, 95834), and current telephone number (916-574-8900) or (888) 370-7589), pursuant to CEC §94909(a)(3)(A).</p>

3	CEC §94909(a)(9)	<p>Violation Description: The institution's catalog failed to include the schedule of total charges for a period of attendance and estimated schedule of total charges for the entire education program.</p> <p>Correction: The institution shall update the catalog to include the above information, pursuant to CEC §94909(a)(9).</p>
4	CEC §94909(a)(8)(B)	<p>Violation Description: Although page 18-19 of the institution's catalog includes the refund policy, however failed to include a description of the procedures that a student is required to follow to cancel the enrollment agreement or withdraw from the institution and obtain a refund.</p> <p>Correction: The institution shall update the catalog to include the above information, pursuant to CEC §94909(a)(8)(B).</p>
5	5, CCR §71810(b)(13)(A)	<p>Violation Description: The institution's catalog failed to include the housing information for the institute's location in the state of California. (A) Whether the institution has dormitory facilities under its control.</p> <p>Correction: The institution shall update the catalog to include the above information, pursuant to 5,CCR §71810(b)(13)(A).</p>

9	5, CCR §76215(b)	<p>Violation Description: Although pages 1 and 2 of the institution’s enrollment agreement, contains the required disclosure however, the statement references the Bureau’s old address and the old telephone number.</p> <p>Correction: The institution shall update the enrollment agreement with the Bureau’s current address (1747 North Market Boulevard, Suite 225, Sacramento, California, 95834), (916-574-8900) or (888) 370-7589), pursuant to 5, CCR §76215(b).</p>
10	CEC §94911(j)(1)	<p>Violation Description: Although page 2 of the institution’s enrollment agreement, contains the required disclosure however, the statement references the Bureau’s old address and the old telephone number.</p> <p>Correction: The institution shall update the enrollment agreement with the Bureau’s current address (1747 North Market Boulevard, Suite 225, Sacramento, California, 95834), (916-574-8900) or (888) 370-7589), pursuant to CEC §94911(j)(1).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
