Yvette Johnson issues this Modified Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Enforcement Chief of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Modified Citation is hereby issued to Rafael Gonzalez for allegedly operating Truck Nation School located at 6801 McComber Street, Sacramento California 95828 pursuant to Business and Professions Code Section 148; California Education Code (CEC) Section 94944; and Title 5 of the California Code of Regulations (5 CCR) Section 75020 for the violation(s) described below.

#	The California Education Code (CEC) and the California Code of Regulations (CCR). Below you will find the section(s) you are charged with violating.
1.	<p><b>Violation:</b> CEC 94886 – Approval to Operate Required. <i>“Except as exempted in Article 4 (commencing with Section 94874) or in compliance with the transition provisions in Article 2 (commencing with Section 94802), a person shall not open, conduct, or do business as a private postsecondary educational institution in this state without obtaining an approval to operate under this chapter.”</i></p> <p><b>At the conclusion of the Bureau’s investigation, the Bureau finds that Truck Nation School, a private postsecondary institution, has been operating, providing instruction for a truck driving license, and collecting tuition from enrollees without obtaining an approval to operate, in violation of CEC</b></p>

Section 94886 as specified above. The Bureau alleges that Rafael Gonzalez was an operator of Truck Nation School.

**Order of Abatement:**

1. Rafael Gonzalez shall pay restitution to student J. E in the amount of \$2,800 and student D.S. in the amount of \$2,000.00 and to all students identified by Respondent whose enrollment agreements were for a total amount exceeding \$2,500. Respondent will refund any deposits made, but successful graduation from Truck Nation School was not completed due to the closure of a branch location or if a student had made a timely request for a refund. All payments are to be arranged directly by Respondent who shall provide proof of payment to the Bureau within 60 days (April 29, 2016) of the executed settlement agreement. Respondent has determined that the records show there were 15 enrollment agreements that were for an amount in excess of \$2,500. The records further show that the amount actually collected for these 15 enrollment agreements plus students J.E. and D. S. totaled \$9,120.00. Respondent shall make refunds to students J.E, and D.S. and to the 15 students identified by Respondent via cashier's check, official bank check or money order.
2. Respondent shall pay an administrative fine in the amount of \$15,880, to the Bureau, with payments of \$2,000 per month commencing 90 days from the date of the settlement agreement (May 29, 2016) until paid in full. The last payment is due no later than February 5, 2017. This administrative fine is separate from the repayment to students.

**TOTAL ADMINISTRATIVE FINE DUE: \$15,880.00**

ASSESSMENT OF FINE

In accordance with CEC 94944; and 5 CCR Section 75020(b) the Bureau hereby issues this assessment of fine in the amount of \$15,880.00 for the violation(s) described above. Monthly payments in the amount of \$2,000 are due and payable to the Bureau no later than the 5<sup>th</sup> of each month commencing 90 days from the date of the settlement agreement (May 29, 2016) until paid in full. **The first payment is due no later than June 5, 2016.** Payment will be accepted via check or money order. No personal checks or credit cards are accepted.

ORDER OF ABATEMENT

In accordance with the provisions of 5 CCR Section 75020 the Bureau hereby issues the order(s) of abatement described above. Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 60 days (April 29, 2016) from the date of service of the Modified Citation.

BACKGROUND

On March 24, 2014, the Bureau issued a Citation: Assessment of Fine and Order of Abatement No. 1314006 to Rafael Gonzalez for operating an unapproved institution.

On June 10, 2014, the Bureau issued an Affirmed Citation: Assessment of Fine and Order of Abatement ordering Truck Nation School to cease operating as a private Postsecondary Educational Institution.

PAYMENT OF ADMINISTRATIVE FINE
