On February 28, 2019, an informal telephone conference was held in the matter of Citation: Order of Abatement No. 1819097 (Citation) against The William Carey International University, Owner of William Carey International University. In attendance were Beth Scott, Enforcement Chief; and Tom Rutherford, Registrar.

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1819097.

It is the decision of the Enforcement Chief that on February 28, 2019, Citation No. 1819097 is modified and makes the following change(s):

VIOLATION CODE SECTIONS

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
1.	<p>MODIFIED Violation: CEC Section 94885(a)(6) and (9)- Minimum Operating Standards <i>"(a) The bureau shall adopt by regulation minimum operating standards for an institution that shall reasonably ensure that all of the following occur: [...]</i> <i>(6) The institution is financially sound and capable of fulfilling its commitments to students. [...]</i> <i>(9) The institution is maintained and operated in compliance with this chapter and all other applicable ordinances and laws."</i></p> <p>5, CCR Section 71745(a)(6)- Financial Resources. <i>"(a) The institution shall document that it has at all times sufficient assets and financial resources to do all of the following: [...]</i> <i>(6) Maintain a ratio of current assets to current liabilities of 1.25 to 1.00 or greater at the end of the</i></p>

most recent fiscal year when using generally accepted accounting principles, or for an institution participating in Title IV of the federal Higher Education Act of 1965, meet the composite score requirements of the U.S. Department of Education. For the purposes of this section, current assets does not include: intangible assets, including goodwill, going concern value, organization expense, startup costs, long-term prepayment of deferred charges, and non-returnable deposits, or state or federal grant or loan funds that are not the property of the institution but are held for future disbursement for the benefit of students. Unearned tuition shall be accounted for in accordance with general accepted accounting principles."

For the reasons stated above, the institution is in violation of these sections of law.

Reason for modification: Compliance obtained; Abatement satisfied.

APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this modified Citation. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code. If you did not initially request an Administrative Hearing within 30 days from when the original citation was issued, you can no longer request one.

If you do not wish to appeal this modified Citation you must withdraw your initial request for an Administrative Hearing, if one was made. Please complete and mail the enclosed Withdrawal - Request for Administrative Hearing within **30 Days** of the date of this decision.


