22 1. On or about April 9, 2014, Joanne Wenzel, Chief of the Bureau for Private
23 Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), filed
24 Statement of Issues No. 998491 solely in her official capacity.

25 2. On or about October 18, 2004, the Bureau for Private Postsecondary and Vocational
26 Education¹ (hereinafter "BPPVE") issued Ariel Hubbard, 73% Owner; Ronald Dunham, 24%

27 ¹ The former Bureau for Private Postsecondary and Vocational Education sunsetted on
28 July 1, 2007. On October 11, 2009, the Bureau for Private Postsecondary Education Act of 2009

1 Owner; and, Mark Musgrave, 2% Owner, an Approval to Operate California Academy for the
2 Healing Arts, Inc. (Respondent). The Approval to Operate expired on August 11, 2011.

3 3. On or about August 11, 2011, the Bureau received an "Application for Renewal of
4 Approval to Operate and Offer Educational Programs for Non-Accredited Institutions"
5 (Application #23852) from Respondent. On or about August 8, 2011, Ariel F. Hubbard certified
6 under penalty of perjury to the truthfulness of all statements, answers, and representations in the
7 application. The Bureau denied the application on September 21, 2012.

8 4. The basis for withdrawing the pending Statement of Issues No. 998491 is that
9 Respondent is withdrawing her application for Renewal of Approval to Operate a Non-Accredited
10 Institution (Application #23852) and her request for hearing.

11 5. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 998491
12 is hereby withdrawn without prejudice.
