STUDENTS RIGHT TO CANCEL

STUDENT'S RIGHT TO CANCEL/WITHDRAW: Institutions shall refund 100% of the amount paid for institutional charges, less a reasonable deposit or application fee not to exceed two-hundred and fifty (\$250.00), if notice of cancellation is made through attendance at the first class session, or the seventh class day after enrollment whichever is later. The student has the right to withdraw from a program of instruction at any time. Cancellation or withdrawal shall occur when the student provides written notice to the institution at the address specified in the agreement (University of Antelope Valley, 44055 Sierra Highway, Lancaster, CA 93534). Students may be withdrawn by the University for Conduct, including, but not necessarily limited to, lack of attendance. Upon cancelling or withdrawing, all money due to the student will be refunded within 45 days of date of determination.
