### Students Right to Cancel and Refund Right

- 1. You have the right to cancel the enrollment agreement for a program if instruction including equipment or other goods and services included in the agreement, through the first-class session or the seventh day after enrollment, whichever is later.
- 2. Cancellation shall occur when you give written notice of cancellation to the school. You can do this by mail, fax, hand delivery, or telegram. - 3. Subtotal = \$1,175.00
- 4. Less any amount paid by you or on your behalf = \$1,000.00
- 5. Amount you still owe = \$175.00

For the purpose of determining the amount owed for the time attended, a student shall be deemed to have withdrawn from the course when any of the following occurs: (a) The student notifies the school of his/her withdrawal or the actual date of withdrawal in writing. (b) The school terminates the student's enrollment. (c) The student fails to attend classes for 5% of the program's duration.
